What Services Does Rehab Assist Provide?

- *Life Care Planning* – Lifelong medical needs and costs are detailed and projected in a report called a Life Care Plan. These documents are helpful in setting long-term financial reserves. Rehab Assist professionals have vast experience in deposition and trial testimony.
- *Comprehensive Disability Assessments* – These documents provide a thorough review of an individual's status and the future services they will require. They are most beneficial to families, "payers" and the court in planning for future needs.
- *Annual Medical Budgets* – These documents assist the estate-planning team to budget and plan for necessary medical and disability-related expenditures. Probate courts often require this type of projection when analyzing the financial needs of a disabled individual. Special situations such as high tech medical care, special needs trusts or nursing waiver programs can be identified and budgeted for by the case manager.
- *Case / Care Management* – Highly trained professionals evaluate the needs of the individual and coordinate the necessary services required to meet those needs. These services are provided to pediatric, adult, and geriatric clients on a long term on-going basis or for a shorter duration.
- *Guardianship* – Under the jurisdiction of the probate court, Rehab Assist serves as guardian of the person for persons who have been adjudicated disabled. These services include plenary guardian, limited guardian and co-guardian.
